



Vendor Registration Agreement

The SmokeRise BBQ, Inc/Que4Kids, (hereafter known as SB/Q4K) staff invites you to participate at our BBQ Competition on May 14th, 2011 at Chehaw Park in Albany, GA.

BASIC Booth Fee is \$50.00. Food vendors MAY be charged a different fee. The signed contract and full Payment is due on or before April 30th, 2011, unless otherwise approved. You are welcomed to contact Mark Little at 770-500-9826, or email Mark at smokerisebbq@yahoo.com to discuss anything pertaining to vendors.

All basic booths are 10'X10'. Power and additional booth space will be negotiated PRIOR TO REGISTRATION.

Complete, sign and return this agreement with ALL fees due (non-refundable) to PO Box 184, Pineview, GA 31071.

Participating Vendors are by invitation ONLY. Please respond in a quick and timely manner as these booths will be assigned on a first come/first serve basis. We will attempt to facilitate any reasonable request. If full payment is not received by set up, SB/Q4K reserves the right to sell your booth space to another vendor. Please note, **THERE WILL BE NO REFUNDS DUE TO INCLIMATE WEATHER, OE NON-PERFORMANCE OF VENDOR.**

All booths must be set up and stocked by 10:00 PM on Friday, May 13th. Special arrangements for later set up must be approved, in writing, by SB/Q4K. Booths must be inventoried and staffed for opening to the public by 9:00 AM Saturday, May 14th.

Vendors will obey and abide by the rules listed below. They are for the fun, enjoyment, and safety of everyone. Anyone breaking this agreement will be asked to leave the event, with all booth fees forfeited. If you ANY questions regarding the items you plan to sell, or your booth, please contact Mark Little @ 770-500-9826.

Rules

- 1) Electrical Power: Power will be provided to those who need it at a nominal additional price. Contact Mark with your power needs. Vendor provides all items needed to distribute power, (Extension cords, surge protectors, etc)
- 2) Vendor will provide all booth items needed. (Chairs, Tables, Etc.) Tents must be clean and presentable.
- 3) No illegal drugs allowed on premises at any time. If any are found, or anyone is exhibiting behavior of being under the influence of ANY drug, the vendor and all staff will be escorted off of the premises by the local authorities, and all fees will be forfeited.
- 4) No loud music. Music is allowed in the booth at a tolerable level.
- 5) Pets ARE allowed at the event, but only in the event area. Pets are not allowed in the ZOO area. They must be kept on a six foot leash. The owner assumes all responsibilities for their animal.
- 6) Booths will be open from 9:00AM until 5:00PM. Unauthorized early breakdown will result in the vendor not being allowed back.
- 7) The vendor will be solely responsible for the operation and supervision of the booth. All food vendors are required to contact the local health department, (Lee County) and notify them of their participation. All food vendors are solely responsible for adhering to all food safety laws and regulations.
- 8) **All** Vended Items subject to Event approval.
- 9) Weapons of ANY kind may not be sold.
- 10) Vendors must abide by all local, state, and federal laws. It is the vendor's responsibility to know these laws. Vendor is solely responsible for collection and payment of all Sales Taxes required.
- 11) Any pictures, (still or video) sound recordings, paintings or drawings gained by SB/Q4K may be used for future advertising without the consent of the vendor.

12) The undersigned individual hereby agrees to indemnify SmokeRise BBQ, Inc, Que 4 Kids, all agents, heirs, successors, assignees and all others persons claiming through them from any claims, demands, cause of actions, liability, loss, damage, costs or judgments which may be rendered against the Chehaw Park Authority, Chehaw Park Executive Director, department heads, division heads, supervisors, and all employees, heirs, agents, successors, assignees and all other persons claiming through them regarding injuries or death to the undersigned and any of the undersigned's employees, family, guests, invites or licensees who come on to the property where activities of SB/Q4K are being held. The undersigned agrees to indemnify the Chehaw Park Authority, the SB/Q4K, Chehaw Park Executive Director, department heads, division heads, supervisors and all employees, agents, heirs, successors, assignees, and all other persons claiming through them, for any and all liability, loss, or damage the said people, firms, or other entities may suffer as a result of claims, demands, costs or judgments against the arising out of, related in any manner, however indirectly, for loss as a result of the undersigned, and undersigned's employees, family, guest, invites of which is jointly and severally acknowledged, the undersigned covenants for themselves, their respective heirs, legal representatives, and assigns, to irrevocably bind themselves to refrain from making any claim against Chehaw Park Authority, SB/Q4K, Chehaw Park Executive Director, Department Heads, division heads, supervisors, and all employees, any heirs, assignees, legal representatives or any other person, firm, or entity claiming by or through the, for loss described above. The undersigned expressly agrees that this instrument may be treated as a defense to any action or proceeding that may be brought, instituted, or taken by the undersigned or in their behalf, and shall forever be a complete bar to the commencement or prosecution of any action or preceding whatever against The Chehaw Park Authority, SB/Q4K, Chehaw Park Executive Director, Department Heads, division heads, supervisors, and all employees, any heir, legal representatives, assignee or any other person, entity or firm claiming by or through them. The indemnity herein before set out is clearly intended to include all expenses of litigations, costs, attorney's fees and any other expenses related to loss as described above on said property.

Camping sites may be available to vendors, on a first come, first serve basis. Sites are limited. Call Mark at 770-500-9826 for information on available camping sites. Special hotel rates may be negotiated for our vendors at a nearby hotel. It is suggested that you inquire about special rates before you book a hotel room.
